Sub: Implementation of revised procedure for release of funds and monitoring utilization of funds under RUSA (CSS)

Madam/Sir,

With reference to the subject cited above, I am directed to inform that the Government of India in MHRD has revised the procedure for release of funds under RUSA from this year onward as mentioned below.

- 1. From now the funds released under RUSA by MHRD will be kept in a Single Nodal Account (SNA) opened by the Department at headquarters level, i.e., in State Bank of India, Secretariat Branch, Bhubaneswar. Accordingly, an account has been opened in the name of "SNA RUSA ODISHA" bearing number-40314029573 & IFSC SBIN0010236.
- 2. Beneficiary Universities/Colleges shall open a zero balance subsidiary account in a local branch of SBI in their name. To facilitate opening of such zero balance subsidiary accounts, Higher Education Department will share a Google Form link with the beneficiary Universities/Colleges for collecting the KYC details of the co-signatories of RUSA accounts of the beneficiary Universities/Colleges. This account will exclusively deal with all transactions relating to RUSA.
- 3. All zero balance subsidiary accounts will have allocated drawing limit to be decided by the H.E. Department from time to time. When the need to pay arises, the University/College concerned will generate a Print Payment Advice (PPA) in PFMS and present the same in the local SBI branch having its zero-balance account. On successful processing of the PPA, the amount will be debited from the SNA and credited in the account of the end beneficiary; passing through the zero-balance account of the University/College concerned. The available drawing limit of the zero-balance account will get reduced by the extent of such transaction. The HE Department will enhance the drawing limit from time to time depending on the progress of expenditure.
- Before operationalization of this revised procedure, the RUSA beneficiary Universities/Colleges shall have to permanently close their all existing RUSA Accounts

(including FDs, TDs, etc. if any) on 06.08.2021 and transfer the closing balance amount, including interest accrued upto the closing date, to the SNA on 06-08-2021 itself; failing which the institution will be debarred from getting any grant under RUSA in future and also be liable for punitive action for unauthorized retention of Central Government and State Government money.

 The beneficiary Universities/Colleges shall submit an undertaking in the format enclosed by 10.08.2021 regarding compliance of the instruction contained in Para-4 above. (Annexure-A)
