**AND**

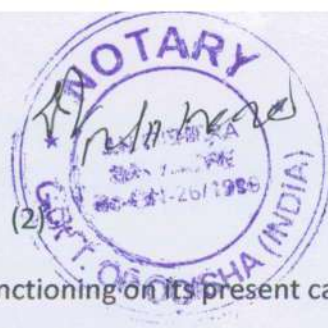

### Objectives

The goal is to foster collaboration, provide opportunity for global experience, and to facilitate advancement of knowledge on the basis of reciprocity, Remuna Degree College and Sriram Chandra Sanskrit College, Bateswar, agree:

- To exchange information on teaching, learning and other literature to their educational and research programs.
- To exchange, on a reciprocal basis students at undergraduate level for purpose of education.

### Entry into force Duration and Termination

- The MOU shall enter into force on the date of signing.
- This MOU shall remain in force for a period of five (5) years and may be extended for another period of 5 years by mutual written consent of the parties.
- Either parties may terminate this MOU at any time by giving written notification to the other party on its intention to terminate this MOU six (6) month prior to the date of the termination.
- It may be modified by written mutual consent of both parties.
