Department of Physics of Remuna Degree College, At-Srikrushnapur, Po-Remuna, Dist-Balasore, 756019, Odisha represented by the Principal, Mrs. Jayanti Nayak, aged about 46 years, First party.

AND

Department of Physics of Swarna Chuda Degree College Mitrapur, Dist-Balasore-756020, Odisha represented by the Principal, Dr. Sarata Chandra Panigrahi, aged about 59 years, second party.

Whereas both the parties are Degree Colleges in the District of Balasore got recognition as a Degree College by the Department of Higher Education, Government of Odisha being affiliated to the Fakir Mohan University, Balasore.
